**No. C.2002/2025**

Hon'ble the Chief Justice, on the recommendation of the "Gujarat High Court Rules Committee and District Judiciary Rules Committee" under Section 123 of CPC, is pleased to issue the following Circular for the District Judiciary of the State of Gujarat **in supersession of earlier Circular No.C.2002/2025, dated 28.10.2025 :-**

***"A4 size paper be used uniformly in all jurisdictions for all kind of pleadings contained in petitions, affidavits, applications or other documents etc, and all memorandum of appeals, orders and judgments in all District Courts of the State of Gujarat.***

The A4 size paper to be used as above shall conform to the following specification of paper and formatting style :-

***Superior quality A4 size paper (29.7 cm x 21 cm) having not less than 75 GSM with printing on both sides of the paper with Gujarati Font - Lohit Gujarati/ Noto Sans Gujarati/ Noto Serif Gujarati, Font Size 13 and/or with English Font - Times New Roman, Font size 14, in one and half line spacing (for quotations and indents - font size 12 in single line spacing), with margin of 4 cm on left & right and 2 cm on top & bottom."***

This circular shall come into force w.e.f. **01.01.2026**.
